In accordance with Section 103 of Article 5-A of the General Municipal Law, sealed Bids for the construction of the Project will be received at the office of the Town of Farmington, located at 1000 County Road 8, Farmington, New York 14425, until April 15, 2025, at 2:00 PM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Project involves the road reconstruction on Cranberry Drive including: removal of the existing pavement, subbase, concrete gutters, storm sewer pipe and structures, and installation of new road base and asphalt pavement courses, concrete gutters, storm sewer pipe and structures. Project also includes watermain replacement and replacement of the underground electric to the existing streelights.
