IMPORTANT NOTICE

Required Inspections of Existing Residential Septic Systems

The Town of Farmington adopted a sanitary treatment law on January 23, 2024 incorporating the provisions of the Uniform Procedures Program of the Ontario County Soil and Water Conservation District. The law requires that prior to the transfer of real property an inspection shall be made of existing wastewater treatment systems.

The Town of Farmington contracted with the Ontario County Soil and Water Conservation District January 24, 2024 to provide inspection services for all properties in the Town of Farmington.

Inspections by others **will not** be accepted.

A complete inspection shall consist of an inspection of the interior plumbing, septic tank (prior to, during pumping and after pumping), baffles: inlet and outlet, the location and condition of the distribution box and leach area. A dye test shall be performed, if warranted, and an assessment made of the physical surroundings.

The Inspector shall furnish a written report which will include a copy of the site inspection report and a sketch of the system with dimensions.

As of January 1, 2004, the New York State Education Department with the New York State Department of Health require, under the New York State Education Law, all systems receive a review and a signed or stamped design by a licensed design professional. New systems and replacement leach fields require a Building Permit and will be reviewed either by NYS DOH or the Town Engineer.

A copy of the Individual Onsite Wastewater Treatment Systems Code (Chapter 126) is available for review in the office of the Building Department at 1000 County Road 8, Farmington NY 14425.
